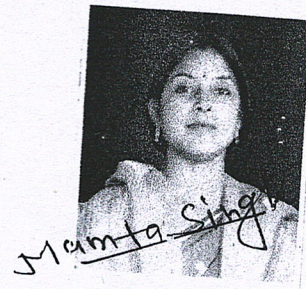

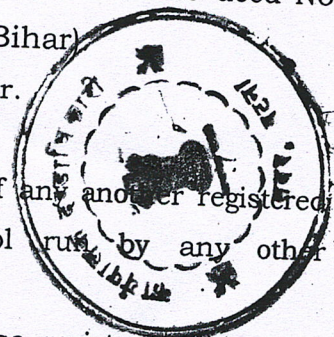

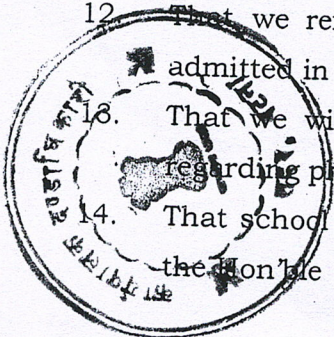

8. That we publicly notify tuition fee/charges, annual audit and annual report in Parents Teacher (PT) meeting and on the notice board.
9. That we undertake we will follow all conditions of departmental Notification No. 238 Dated 04.04.2006.
10. That we take 25% admission under RTE Act.
11. That we do not conduct the admission test or interview from the students/Guardian for the admission in Nursery, KG and Primary.
12. That we refund 100% registration fee in case of those students who have not admitted in the school for any reasons.
13. That we will follow the condition as per Notification No. 46 dated 18.01.2008 regarding physical punishment to the students.
